

# Latin America and the Caribbean Regional Briefing for 10YFP National Focal Points

"Multilateral Cooperation on SCP post-2022"

4th June (Spanish) and 2nd of July (English) 2021

#### SUMMARY REPORT

The Regional Briefing for Latin America and the Caribbean Regional Group (GRULAC) for the 10-Year Framework on Sustainable Consumption and Production (10YFP) post-2022 was held in two sessions: in Spanish (4th June) and in English (2nd of July).

The session in Spanish was chaired by Argentina, Sr. Rodrigo Rodríguez Tornquist, Secretary of Climate Change, Sustainable Development and Innovation, Ministry of Environment and Sustainable Development as Chair of the 10YFP Board and representative for the Latin America and Caribbean States. The session in English was facilitated by the 10YFP Secretariat.

Both sessions followed the same objectives that are included in the Annex of this report together with the Agendas and presentations.

This report summarizes the presentations and discussions of both sessions.

#### Introductory remarks from Sr. Rodrigo Rodríguez Tornquist, Chair of the 10YFP Board:

In the opening remarks, the following was conveyed:

- The 10YFP is mandated to implement Sustainable Development Goal 12.1 until 2030, however the 10YFP mandate ends in 2022.
- We need sustainable consumption and production (SCP) solutions in order to achieve the targets in Multilateral Environmental Agreements (MEAs) set by countries to address the three planetary crises of climate change, biodiversity loss and pollution.
- International cooperation and coordinated action are the key for transitioning towards the global, sustainable and equitable economy required to deliver the goods, services and welfare that we need.
   This is especially important in the context of post-COVID 19 pandemic recovery.
- In the Latin America and the Caribbean region, SCP is recognized at the highest level through the
  decisions of the Regional Forum of Ministers of Environment. The latter is supported by the Regional
  Council on SCP, that is specialized entity composed of SCP experts. It is, therefore, important to
  connect the 10YFP post- 2022 process to the regional agenda supported by the Forum of Ministers
  for Environment
- The post-2022 process is our opportunity to broaden and reinforce action on SCP in a transformative way, building on past experience and lessons learned.
- This is the first ever meeting that brings together 10YFP National Focal Points with focal points from Multilateral Environmental Agreements (MEAs) to gather insights. All inputs will be documented to feed into the next Strategy for multilateral cooperation on SCP.



#### Towards global leadership and action on Sustainable Consumption and Production (SCP)

The key elements agreed with the 10YFP Board and the larger Group of Friends on SCP, established in 2020, on the 10YFP Post-2022 were summarized as follows:

- There is a large consensus on maintaining the integrity of the 2030 Agenda in which the 10YFP has a
  mandated role and the need for a continued mandate for multilateral cooperation on SCP (as per
  A/Conf.216-5).
- A common strategy is required for multilateral and multi-stakeholder cooperation on SCP beyond 2022 that reflects political ambition through priorities and objectives.
- Sustainability agendas need to be more integrated, with SCP to serve as an instrument to connect conventions and multilateral environmental agreements, and support implementation.
- The importance of building on science to bridge gaps and help decision-makers understand the economics underpinning SCP, including through strengthened cooperation with the International Resource Panel, and support the application of the value chain approach for prioritization.
- The need to ensure Member States engagement and commitments to translate into action and implementation.
- The need to review of experience since 2012, building on the capacity and experience of the One Planet network.
- The importance of a global movement for SCP: mobilizing and building on the One Planet network, engaging other alliances, platforms and partnerships.
- The need to strengthen engagement with the wider UN system and the 10YFP.

#### Opportunities for mainstreaming SCP into Climate, Biodiversity and Pollution and Waste agendas:

 Multiple examples were provided that demonstrate how SCP policy instruments and tools contribute to achieving targets on climate, biodiversity, pollution and waste. Such as:

#### Dominican Republic:

- National SCP actions such as cleaner production award and establishment of sectoral publicprivate partnerships that result in a decrease of GHG emissions and waste generation;
- Development of National SCP roadmap that supports the integration of SCP in different institutions and levels of government, including budget allocation needed for its implementation.

#### Costa Rica

- Economic incentives such as those that support ecosystem services;
- Introduction of sustainability criteria in public procurement practices

#### Colombia

- Circular economy as a way to transform production and consumption and as a result reduce emissions, use of chemicals, waste and biodiversity loss.
- Opportunities were presented to mainstream SCP into agendas for UNFCCC, BRS Conventions, UNCDD and the Convention on Biological Diversity and SAICM including:
  - 1. Opportunities to mainstream SCP into current processes.
  - 2. Through the SCP approach, a value chain/systemic analysis can enable the identification of hotpots and drivers in high-impact sectors driving the environment crises addressed by the international agendas and conventions.





- 3. Based on this scientific and systemic knowledge of hotpots and drivers; priority actions can be identified and integrated into national action plans for the different Conventions and agendas.
- 4. Opportunities to provide guidance on SCP indicators and SCP reporting across MEA targets

Inputs provided by 10YFP and MEAs regional Focal Points on the future of multilateral cooperation on SCP post-2022 can be highlighted as follows:

- The need to ensure linkages between the 10YFP post-2022 process and the regional agenda aligned with the Forum of Ministers for Environment (Decision 2 on SCP) for the Regional Council on SCP as well as multilateral discussions on trade.
- The 10YFP is recognized as an important platform for global cooperation on SCP: there is a strong
  need for regional and international cooperation on SCP and the 10YFP provides a good platform for
  this.
- The need to reinforce the link between SCP and the three planetary crises climate change, biodiversity loss and pollution -, as well as the link with economic & trade agendas.
- The need to strengthen the science-policy interface and the availability of environmental information and data through tools such as the SCP-Hotspot Analysis Tool that inform the development of evidence-based public policy.
- To avoid duplication and ensure alignment of action and integration of agendas, there is a need for
  multi-stakeholder and cross-institutional collaboration that allows for actors at different levels within
  the government, and from different sectors and stakeholder groups to work together.
- The importance of changing behaviour and engaging consumers as citizens in the SCP transition, including through environmental education to boost the role of consumers in SCP and to raise awareness on resource use and consumption impacts.
- The need for inspiring, simple and actionable language on SCP and demonstrate the interconnections with the long-term economic and social risks of unsustainable consumption and production patterns. Communication efforts could be focused around one concept or an issue specific to a particular region/sector to make it relatable and concrete.
- The need for SCP champions, as in the area of climate change, with the aim to raise awareness and attract attention to unsustainable consumption and production as a root cause of the global crises the world is facing.
- The need to strengthen coordination between the public and private sectors for the provision of specific incentives and subsidies aligned with the needs and capacities of the private sector to shift to sustainable practices.
- The need to strengthen monitoring systems for SCP.
- More effort is required to connect actors at sub-national, national, regional, and global levels, including to assure alignment of action and share knowledge, experiences and best practices on SCP.

#### Highlights regarding the role of National Focal Points in the 10YFP Post 2022:

- **Connecting focal points through SCP:** it is important to link the 10YFP National Focal Points to Focal points from the different agendas on Climate, Biodiversity and Pollution and Waste.
- The 10YFP can support the National Focal Points to create linkages between SCP and different agendas and activities to avoid overlap. This includes identification of entry points in MEAs where SCP tools





and solutions could be most useful. Establishing such linkages provides opportunities to access finance as they allow to demonstrate potential synergies, complementarity and simultaneous benefits that support the achievement of different agendas through SCP.

• The role of the National Focus points to promote SCP and connect various agendas could be strengthened through the **provision of trainings and materials in Spanish as well as in English.**

#### Annex 2: Background and Agendas (English and Spanish Sessions)

El 10YFP también está plasmado en la Agenda 2030 bajo las metas 12.1 y 8.4 de los Objetivos de Desarrollo Sostenible (ODS). La reflexión sobre el futuro del 10YFP post-2022 fue iniciada por la Junta Global del 10YFP en 2020 con otros Estados Miembros que lideran el 10YFP como un como un esfuerzo colectivo para construir una visión post-2022 para la cooperación multilateral en Consumo y Producción Sostenibles (CPS). #### **REGIONAL BRIEFING SESSION (ENGLISH) 2nd July:**

#### Background:

The 10-year framework of programmes on sustainable consumption and production (10YFP) was adopted at Rio+20 for the period 2012-2022. The 10YFP is also reflected in Agenda 2030 under Sustainable Development Goal targets 12.1 and 8.4. The reflection on the 10YFP post-2022 was initiated by the 10YFP Board in 2020 with other Member States leading the 10YFP as a collective effort to build a post-2022 vision for multilateral cooperation on Sustainable Consumption and Production (SCP). The 10YFP National Focal Points have a key role in this reflection process to ensure that the next phase builds on their experiences and insights.

**Objectives:** The specific objectives of the briefing are to:

- Introduce the post-2022 vision and recommendations of the 10YFP Board as well as next steps in the process to the 10YFP National Focal Points;
- Gather relevant information on the national context that national governments are facing regarding implementation of multilateral environmental agreements and the 10YFP, and their translation into national policy instruments;
- Discuss options for streamlining messaging on SCP across the relevant agendas of the upcoming events and meetings.

#### **Expected Outcomes:**

- 1) The 10YFP National Focal Points (NFPs) are briefed on the 10YFP Board's vision and ongoing processes for the 10YFP post-2022. The 10YFP NFPs know how they can get involved and contribute to the post-2022 process.
- 2) Insights from the 10YFP NFPS on the implementation of multilateral environmental agreements, and the 10YFP are documented, clarified and put into the context of the post-2022 process.
